Regional Races held at Aldershot, Chatham, Welwyn, Swadlincote and Pendle.

English Finals and Open Competition to be held at Norwich. British Finals to be held at Swadlincote.

NOTE:

- These events are held at public venues for which ESSKIA is not responsible. Responsibility for operation of the venue including any mechanical equipment lies with the slope operator.
- Responsibility for supervision of athletes outside of the competition area (defined as the start area, race slope and finish area) lies with Schools and their appointed representatives. Schools are reminded that as a condition of membership schools should follow their own procedures in respect of checking the appropriateness of any third parties they appoint to supervise or manage their teams.
- Snowsport England and ESSKIA remind Schools that when appointing third-parties to coach their athletes they should ensure that the coach is suitably experienced, holds appropriate qualifications and is acting only within relevant certifications.

ESSKIA is responsible only for operation of the race within the competition area.

This risk assessment applies to the operation of the race itself within the competition area and MUST be read alongside risk assessments of Schools, any third parties they appoint, and the slope operator.

GOOD PRACTICE IS SAFE PRACTICE

To remove risk entirely from any activity is both impossible and unpractical. In the case of inter school competition the challenge for all concerned is to manage the potential risks that young people may face through their participation in competitive sport.

A risk assessment is a careful examination of what could happen to pupils, colleagues or others in a particular situation and/or environment. They are a legal requirement that require the identification and implementation of precautions to minimise or prevent harm.

The role of the risk assessor is to determine whether a hazard is significant and, if so, to determine and implement the precautions necessary to eliminate or minimise the risk presented.

Participating schools should also undertake their own risk assessment for travel to and from the event venue, and ensure they understand their roles and responsibilities in reducing risk at the event.
